is an inherently buoyant, adult life jacket approved for persons with a weight of 43 kg and more and for a height of 155 cm or more. It is designed to fit persons weighing up to 140 kg and a chest girth of up to 1.750 mm, in accordance with IMO Res, MSC.207(81).

Application/Limitation

The adult life jacket is approved for persons with a weight of 43 kg or more and for a height of 155 cm or more.

Retro-reflective materials and position indicating light shall be approved in accordance with the Marine Equipment Directive and bear the MED Mark of Conformity (wheelmark).

The design assessment is based on IMO Res. MSC.48(66) (LSA Code) as amended by IMO Res. MSC.207(81), IMO Res. MSC.218(82), IMO Res. MSC.368(93) and Res. MSC.481(102).

IMO MSC./Circ.922 regarding thermal protective lifejackets (TP lifejackets) is not applicable for this type of lifejackets.
