Application/Limitation

The liferaft shall be packed with a SOLAS A PACK or SOLAS B PACK.

Gas cylinders shall be of an approved type.

Components in the gas inflation system should be approved according to ISO 15738:2019.

The liferaft is intended to be installed with external weak link and a hydrostatic release unit. Float free arrangement to be checked upon installation on board.

Production testing shall be carried out according to IMO Res. MSC 81(70) part 2.

The liferafts may be approved for extended service intervals up to 30 months in accordance with SOLAS Ch. III, Regulation 20.8.3 provided that:

- Such extended service intervals have been approved by the ships flag administration.
- 2. The liferafts are checked onboard in accordance with SOLAS Ch. III Regulation 20.8.3.2 at intervals in accordance with SOLAS Ch. III Regulation 20.8.1.1, according to procedures accepted by the Approved Body.
- 3. The liferafts shall be serviced at approved servicing stations in accordance with the recommendations in IMO Res. A.761(18) at intervals not exceeding 30 months.
